In continuation with our intimation dated November 3, 2025 and November 4, 2025 and pursuant to regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("**Listing Regulations**"), we wish to inform you that the board of directors ("**Board**") of Synthiko Foils Limited ("**Company**") at their meeting held on Friday, November 7, 2025 has considered and approved the Issuance of up to 1,36,08,849 equity shares of the Company of face value of Rs. 10 each, to the Sellers, at a price of Rs. 769.16 per equity share, which is determined in accordance with the provisions of the Companies Act, 2013 and the rules made thereunder and Chapter V of the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018 ("**SEBI ICDR Regulations**"), for consideration other than cash (being utilized towards discharge of Consideration for acquisition of 100 % stake in DC&T on a fully diluted basis from the Sellers), on a preferential issue basis, subject to shareholder and regulatory approval and such other permissions, sanctions and statutory approvals, as may be required
